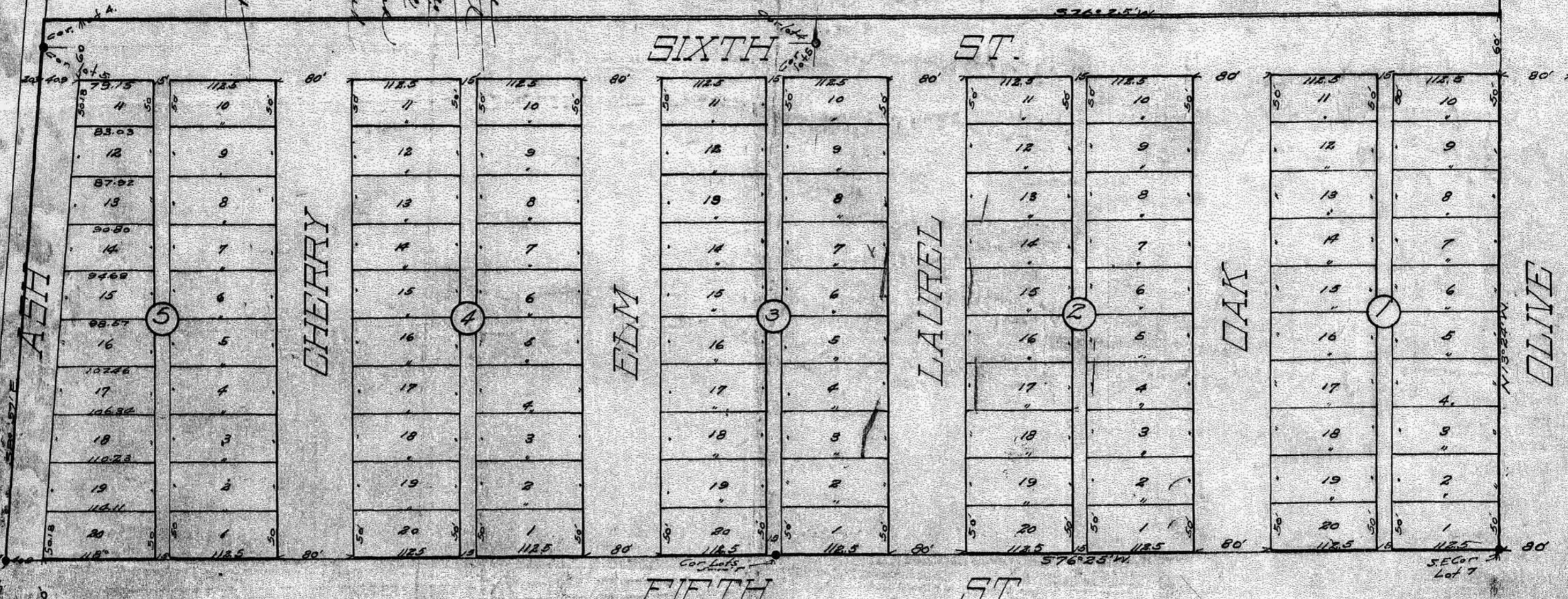


MAP OF BOWERS ADDITION TO THE TOWN OF DAVISVILLE
